#### Proceeds from TVA Community Livability Initiative (\$5,000)

The Loudon County Economic Development Agency received impact funding from TVA for their Community Livability Initiative. The LCEDA created a community livability task force to determine the best use of the funding for our county. The Executive Committee discussed allocating the funds to the Loudon County Chamber with the requirements that they match the dollar amount initiating an updated website which includes a community calendar and non-profit community service portal. <u>John Evans</u> <u>made a motion to recommend granting the proceeds from the TVA Community Livability Initiative to</u> <u>the Loudon County Chamber, seconded by Tony Aikens.
